ORDER:-

In the G.O. 1st read above, a mining lease for Asbestos, Serpentine and Dolomite over an extent of 348.30 acres in S.Nos.193/1A, 193/2etc. of Brahmanapalli Village, Pulivendula Taluk, Cuddapah District for a period of 20years was granted in favour of M/s A.P. Mineral Development Corporation Limited. The lease deed was executed on 5.8.85 and it will be in force upto 4.8.2005.

2. The Director of Mines & Geology in the reference 2nd read above has recommended to permit M/s A.P.Mineral Development Corporation Limited to transfer the above mining lease in favour of M/s Padma Minerals Private Limited for the unexpired portion of the lease period upto 4.8.2005 and subject to giving MRCC by the A.P.Mineral Development Corporation Ltd. before execution of lease deed.

In the circumstances, Government under Rule37[1] of Mineral Concession Rules, 1960, hereby permit the transfer of mining lease heldby M/s A.P.Mineral Development Corporation Ltd. for Asbestos, Serpentine & Dolomiteover an extent of 348.30 acres in S.Nos.193/1A, 193/2 etc. of Brahmanapalli Village,Pulivendula Taluk, Cuddapah District in favour of M/s Padma Minerals Private Limited for the unexpired portion of the lease period upto 4.8.2005 and subject to giving MRCC by the A.P.Mineral Development Corporation Ltd. before execution of lease deed on the same terms and conditions as ordered in the G.O. 1st read above.

4. The transfer lease deed should be executed within three months from the date of receipt of this order and the transferor should pay all mineral revenue dues to the

Government till the date of transfer, before execution of transfer lease deed. The Director of Mines & Geology is requested to take further necessary action in the matter.
